### REPORT OF THE TRUSTEES FOR THE YEAR ENDED 31 MARCH 2017

---

The trustees, who are also directors of the charity for the purposes of the Companies Act 2006, present their report with the financial statements of the charity for the year ended 31 March 2017. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015).

#### **Introduction from the Chair, Robert Fryer**

What you will read in the following report shows that we have significantly expanded our operations over the past year. The number of beneficiaries has grown, as has the number of tasks taken on by more volunteers.

We aim to be better known in the local community, and to further this aim in July we produced the Parsons Green Fair, maintaining a 25 year old tradition, which attracted over 8,000 visitors.

Behind these achievements are our dedicated staff, who deliver our increasingly varied services. May I thank them, the volunteers and the trustees for their continued efforts on behalf of FGNS.

#### **The Charity's Aims**

The objects of the charity are:

(a) to provide assistance to the people of Fulham and surrounding areas in their own homes or elsewhere as may be required arising from age, illness, infirmity, disability or other need.

(b) to provide assistance of the nature referred to above or otherwise to complement services provided by health and social services.

Reference to Fulham means the area of the former Metropolitan Borough of Fulham as constituted on 31 March 1965.

#### **Review of Developments, Activities and Achievements**

The following activities were undertaken during 2016-17. We would like to highlight that much of this work was possible thanks to the grant from London Borough of Hammersmith and Fulham.

#### **Good Neighbour Scheme**

Our volunteers accomplished 422 practical tasks on the Good Neighbour Scheme:

- accompanying to appointments
- transport
- wheelchair pushing
- emergency shopping
- pet care
- IT issues
- letter posting
- respite care
- medication collection
- DIY
- help with correspondence

We have also signposted different individuals to more appropriate services on 151 occasions.

#### **Befriending**

During the course of this year our volunteers provided 229 befriending visits.

#### **Social Clubs**

Many of our beneficiaries suffer from loneliness. We have responded by increasing and improving on the range, format and frequency of our Social Clubs.

Reachout Social Club has been renamed Fulham Lunch Club with the support of a grant from Westfield Shopping Centre. This free Wednesday club now also offers a hot lunch and a range of different speakers and performers. By March 2017 the club had a regular and growing following of locals, most of them over 80 years old. We are grateful for the support of a fellow charity – the Felix Project – who has been supplying us with food for the club since December 2016.

We launched a weekly art group called Art in Nature which has been possible thanks to the support of Care UK Wellbeing Foundation. We also started a weekly Shared Reading Group delivered by one of our volunteers and set up with the help of The Reader Organisation.

We launched a second monthly Lunch Club in addition to the Hollywood Arms Club. The new group takes place every third Tuesday of the month and is hosted by the White Horse on Parsons Green with cakes kindly being donated by Le Pain Quotidien, Fulham.

In total, our beneficiaries attended our social clubs on 731 occasions during the year.

#### **Gardening and Decorating**

During the year we accomplished numerous decorating tasks. We deliberately concentrated on supporting those beneficiaries with highest level of need including those with mental health support needs.

We increased the number of people receiving gardening help. We completed 190 gardening projects for 108 older and/or disabled people. We were delighted that the excellent work of our corporate volunteers Assael Architecture was recognised by them winning the Lord Mayor's Dragon Award.

#### **Connections 4<sup>th</sup> Generations Project**

This new project, funded by the National Grid for a 12 month period, started in February 2017. We assist people over 85 who have been discharged from the Charing Cross Hospital, linking them with social activities in the area.

#### **Anniversary and Awards**

We marked our 50<sup>th</sup> Anniversary with a special celebration in September 2016 for beneficiaries, volunteers, staff and guests. The event was attended over 100 guests and by the President of the charity, Mayor of London Borough of Hammersmith and Fulham, Councillor Mercy Umeh.

We were crowned the Best Charity in Hammersmith and Fulham during the LBHF Brilliant Business Awards in November 2016.

We were shortlisted for the Lord Mayor's Community Partnership Category. Clive Domm, one of our long-standing volunteers, was awarded the Team London Long Service Award.

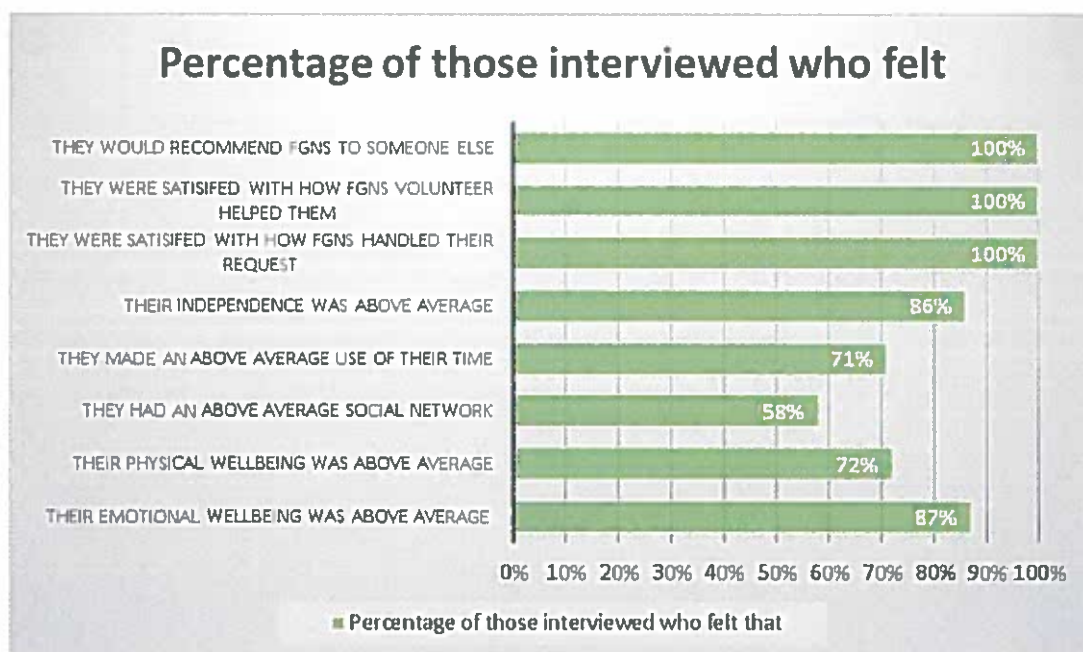

#### Impact, recent developments and plans for future activities

A beneficiaries' survey conducted in July 2016 gave the following results:



Our strategy for our office building includes promoting the space as a meeting point for older people. This we have done, thanks to support from Daisy Trust, Rank Foundation, Percy Bilton Charitable Trust and Yorkshire BS. Their grants enabled us to buy new furniture for the hall. In addition to the new social clubs mentioned above, the space has been used by a group of local older carers, Open Age - to deliver an Expert by Experience programme and to Good Company for All to deliver Sunday Social Afternoons.

Grants from the City Bridge Trust enabled us to conduct accessibility and eco audits of the building.

Thanks to a grant from Smart Energy GB we were able to deliver a range of workshops to groups of older people informing them about the introduction of electric and gas smart meters.

We held our annual Strategy Review Day in January 2017 with staff, volunteers, trustees and stakeholders to create a Strategic Plan for the next 3 years. This plan includes:

- a new website and database matching beneficiaries' requests with available volunteers
- recruiting a Decorating Project Co-ordinator
- acquiring a van for the gardening and decorating projects
- establishing a Men's Shed project
- starting a digital inclusion project
- delivering Parsons Green Fair – a fun day for the local community

#### **Vision, Mission and Values**

##### **Vision Statement**

Fulham Good Neighbours is a local charity enabling neighbours to create a community where they look out and care for each other.

##### **Mission Statement**

Our mission is to enable local older, disabled and vulnerable adults to:

- Live independently and to contribute to society
- Help overcome isolation and loneliness
- Be at the heart of the community by providing practical support

##### **Values**

- Trustworthiness
- Being welcoming and inclusive
- Proactivity and flexibility

#### **Constitution and Organisation**

The charity is governed by its Memorandum and Articles of Association which provide for:

- With his or her consent, the Mayor of the London Borough of Hammersmith and Fulham to be president of the society
- The election of a Trustee Board including Chair, Vice Chair and Treasurer and up to seven other members.

For the purposes of charity law, the Trustee Board is the executive trustee body of the charity. The Trustees and President perform non-executive roles and are regarded as custodian trustees.

##### **Investments**

There are no specific restrictions placed on the trustees' powers of investment by the constitution.

##### **Statement on Public Benefit**

The Trustees have paid due regard to the guidance on public benefit produced by The Charity Commission and are confident that the work of the charity meets all the criteria for public benefit.

##### **Risk and Reserves Policies**

The Trustees believe that risks to the organisation and its property are adequately covered by its insurance and reserves. Our reserves are a mix of designated funds and free reserves. Those funds designated for a specific purpose are retained as such until that purpose is fulfilled.

Our policy is that free reserves should provide the charity with adequate financial stability and the means for it to meet its charitable objectives for the foreseeable future.

The trustees intend, as a minimum, to maintain the charity's free reserves at a level which is at least equivalent to three years' net operational expenditure, taking into account realistic funding streams. Because of exceptional income in 2016, our reserves are strictly in excess of that required by the above policy. However, the charity has agreed plans to broaden and expand its operations substantially which will result in deficits being run for several years. Trustees therefore take the view that the existing free reserves are appropriate in order to realise these objectives.

The trustees review the amount of free reserves that are required to ensure that they are adequate to fulfil the charity's continuing obligations on a bi-monthly basis.

The Trustee Board is required under the terms of certain grants received by the charity to produce financial statements each financial year which give a true and fair view of the state of affairs of the charity and of its financial activities for the that year. In preparing those financial statements, the Trustee Board is required to:

- select suitable accounting policies and apply them consistently;
- make judgements and estimates that are reasonable and prudent;
- prepare the financial statements on the going concern basis unless it is inappropriate to assume that the charity will continue in business.

The Trustee Board is responsible for keeping proper accounting records which disclose, with reasonable accuracy, at any time the financial position of the charity. They are also responsible for safeguarding the assets of the charity and for taking reasonable steps for the prevention and detection of fraud or other irregularities.

So far as the Trustee Board are aware, there is no relevant information of which the charity's Independent Examiner is unaware and they have taken all of the steps necessary that they ought to have taken as Trustees in order to make themselves aware of any relevant information and to establish that the Independent Examiner is aware of that information.

The financial statements were prepared in accordance with the small company regime (Section 419(2) of the Companies Act 2006).



I report on the accounts for the year ended 31 March 2017 set out on pages eight to seventeen.

**Respective responsibilities of trustees and examiner**

The charity's trustees (who are also the directors for the purposes of company law) are responsible for the preparation of the accounts. #### 1. ACCOUNTING POLICIES

##### **Basis of preparing the financial statements**

The financial statements of the charitable company, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

##### **Income**

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

Cash donations, gifts, legacies and collections are treated as income in the year in which they are received. Income from special events and for specific purposes is included in the income and expenditure account in the year the event takes place or the purpose is undertaken.

Income from investments and covenanted income including, where appropriate, imputed tax credits are accounted for on a receivable basis.

Voluntary help is not included in the financial statements.

##### **Expenditure**

Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all costs related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

##### **Fixed assets for charity use**

Fixed assets, other than office premises, are stated at cost less provision for depreciation at 25% per annum on cost.

Freehold property, which represents the Charity's office premises, is stated at cost in accordance with the Statement of Recommended Practice. The freehold property is not depreciated as the revaluation model has been used. Instead, the cost of repairs is charged to the Income and Expenditure Account in the year in which it is incurred.

##### **Taxation**

The charity is exempt from corporation tax on its charitable activities.

##### **Fund accounting**

###### **Restricted funds**

Where a donor has specified a particular purpose for a grant or donation, the income is shown as restricted income in the Statement of Financial Activities. Any such income unexpended at the year end is shown as a restricted fund in the balance sheet. Where grants are received to fund capital expenditure the assets acquired, after any depreciation, are shown as an expendable endowment fund.

###### **Designated funds**

Where funds held for general purposes are allocated by the trustees for specific future uses they are transferred to a designated fund. Expenditure for the purposes specified is deducted from those funds and the unexpended balance is shown as part of unrestricted funds in the balance sheet. If the trustees decide that such funds are no longer needed for the purposes specified the balance of the fund is transferred to general unrestricted funds.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.
