Flora Duley updates us below: "the Covid-19 lockdown restrictions threw us all into self - isolation within our own homes. Online Art Group video sessions quickly emerged with some members learning new technology and overcoming new mental and practical challenges so that they could reconvene, socialise, share

and make art online. The online sessions allowed inspiration to flow: families joined the group, comments came in, doorbells rang, virtual backgrounds were used to share photo albums and

fantasy settings. One member was unable to access the online sessions, however her neighbours and family coordinated weekly time slots in which to photograph her artwork. She held it up at her window! The online exhibition also has a selection from her Window Gallery." The Smile Brigade are running a free meal and delivery service for Hammersmith and Fulham residents who are shielding or struggling financially during the crisis.

Meal recipients can receive deliveries up to 4 times per week with vegetarian, meat, halal, vegan and gluten free options available. Groceries containing fresh fruit and vegetables, toiletries and ready meals are also available for free upon request. All deliveries are made adhering to the government's latest social distancing guidelines with meals delivered directly to people's doorsteps.

The Josiah Braithwaite Community Garden at the Nubian Life

Resource Centre provides a beautiful outside space for the Afro-Caribbean elders who visit. Nubian Life are a key partner of FGN in delivering the Adopt a Garden project. The garden was created using a permaculture design, meaning it is ecological and wildlife-friendly growing mainly edible plants. They run gardening clubs and workshops, although they are online at the moment, the centre hopes to open the garden soon.



They are also participating in Capital Growth's Community Harvest program where we are planting extra vegetables to include in the meals the centre is preparing for vulnerable people in the borough. The Nubian Life centre is looking for a few volunteers who would like to participate in the program and learn about vegetable growing.
